OFFICIAL MEMORANDUM

It was envisaged in the action plan for training in BESCOM for the year 2014-15 to conduct Specific Trainings for the cadre of AEEs, AEs & JEs. In pursuence of this, M/s.CPRI, Bangalore which is a Central Government Establishment with well established facilities and faculty were approached and initial discussions held with them regarding preparing a customized 3 day Residential Training Module for the above cadres. Further discussions between the Director General, CPRI and MD, BESCOM, has culminated in fine tuning and finalising a specific 3 day Residential Training Module at the rate of Rs.9,000/- + 12.36% Service Tax (1,112) – 10,112/- per participant. The proposed Training Program is intended to comprehensively cover various field activities pertaining to the above cadres. To quote a few, the program will cover areas such as Overview of power sector scenario, Concept of losses and Loss reduction measures, Reliability issues, quality of power supply, customer awareness and Satisfaction, cause of DTR Failure, Project management contracts and Electrical Safety aspects etc.

In view of the above, the following candidates are deputed to the 9th Batch of 3 day Residential Training Program on “**Enhancement of O&M Skills**” at CPRI, Prof. Sir C.V.Raman Road, Sadashivanagar, Bangalore from 15-04-2015 to 17-04-2015.
