## NOTIFICATION

**Subject:** Applications invited for Selection posts in ICT & MIS Section of BESCOM from KPTCL and ESCOMs

BESCOM has adopted Information Technology (IT) in its various business operations, one of the major IT initiatives being implementation of RAPDRP Part-A IT project of MoP in the area of Energy accounting covering selected 98 towns across all ESCOMs of Karnataka. RAPDRP Part-A project is implemented involving 17 integrated software modules such as Metering, Billing, Collection, New Connection & Disconnection, Asset Management, Geographical Information System, Meter Data Acquisition, Meter Data Management, Identity & Access management, Management Information System, Energy Audit etc. A Data Centre(DC) and a Disaster Recovery Centre(DRC) common for all ESCOMs on co-hosted model and a Customer Care Centre(CCC) for each ESCOMs are established under the project. Also, under the project, Primary and Secondary MPLS network are established connecting 800+ offices, DGPS based GIS survey is carried out covering around 57,000 kms line length, AMR implementation for 65,000+ DTs and HT consumers and system is serving more than 1 crore consumer base. A centralised GIS Cell is established in BESCOM for GIS related activities. BESCOM as nodal agency is involved in the project from initiation continuously till closure in design requirements, AS-IS & TO-BE documentation, SRS compliances, implementation, System Testing, User Acceptance Testing, End user training & Go-live for successful implementation of the project, and are currently managing the operations and post Go-Live activities by carrying out various administrative and core activities.

BESCOM has recently taken up two prestigious projects viz., IT enablement Phase-II and Enterprise Resource Planning (ERP) under IPDS which are also MoP initiatives. RAPDRP Part-A will get subsumed under IPDS. Under IPDS IT Phase-II, the work is awarded to replace the existing integrated Software solution of RAPDRP with new solution, covering 98 RAPDRP towns and 124 IPDS towns in all ESCOMs. The following works are being carried out under the project:

- DC-DRC Hardware and Software refresh with New/ Upgraded application
- GIS Survey of IPDS towns
- Creating IT infrastructure in IPDS towns
- Supply and installation of modems in IPDS towns.

Also, the work under ERP implementation project is awarded for automation of the back office operations in BESCOM with the modules such as Human Resource Management System (HRMS), Materials (Stores & Purchase), Finance & Accounts, Power Purchase etc.,

Some of the other IT initiatives undertaken by BESCOM are integration with DAS, PGRS, DTLMS, BESCOM Mithra Mobile App, Enumeration of IP Sets, in-house development of SRTPV online

application and FDCS etc., BESCO is establishing its own Data Centre which will be made operational with new hardware procured under IPDS IT Phase-II. The communication network model is being revamped with SDWAN technology and also optic fibre is being laid along the electrical infrastructure.

Further, in order to meet the existing and upcoming business objectives of the organisation, new ICT initiatives will be taken up by BESCO in future using emerging technologies viz., SG, EV, Bots, AI, ML, IoT, Blockchain etc., It is also proposed to have an in-house development & testing team.

BESCO intends to strengthen the existing team to meet the above objectives and growing needs of IT. In this regard, applications are invited for the following selection posts from the interested aspirants of KPTCL, BESCO, CESC, GESCOM, HESCO and MESCOM who wish to be part of the ICT & MIS section, BESCO for the below posts:
