## Preamble:

BESCOM has issued a DWA for 'The Supply and Installation of 12 way HRC Fuse switch based LT feeder pillar box". This 12 way HRC Fuse switch based LT feeder pillar box is designed to provide safety to public as well as our powermen. It was initially planned to use these boxes in model subdivisons. Considering its safety features and other advantages, the board has accorded approval vide ref(3), to utilize these boxes for all other works i.e replacement of deteriorated boxes, new boxes for system improvement works, new boxes which are proposed in the project for conversion of overhead lines to UG cables in Bangalore city, etc. taken up in BESCOM along with the proposed model sub division works.

The budget for carrying out these works for the FY 2019-20 is allotted vide ref(2) under the Budget Head 14-145 (LT strengthening works). It is required that only a work award be issued at Division level in the name of the agency in the DWA cited under ref(1).
