New guidelines have been formulated regarding vendor approval and renewals. As per the above guidelines there will be no vendor renewals.

It has been brought to the notice of the corporate Office that the agencies who have taken up were phase-2 NJ works had already placed orders on the regular supplier who had supplied materials for the first Phase NJS works presuming approval will be extended in a routine way.

In view of the vendor approval / renewal policy, the agencies are facing much difficulty in procuring materials from supplier and will cause delay in execution of 2<sup>nd</sup> Phase NJS works. In order to avoid the delay it is approved to extend the vendor renewals up to 01.09.2012 hence the order.
