For according Vendor approvals, procurement of Materials by BESCOM, procurement of materials by agencies for executing Total Turnkey works, Partial turnkey works, Self-Execution works & for service connection works the materials will have to be type tested by the firm as per IS/IEC/BESCOM specification.

BESCOM is adopting Validity period of type test reports of materials as per CEA guidelines dated: May 2020 vide T.O circular No: GM(QS&S)/DGM-3/BC-11/2020-21/Cys-141 dated: 15.10.2020.

Now Central Electricity Authority, Ministry of power has framed the new guidelines for the validity period of type tests conducted on major electrical equipment's in transmission & Distribution system and Quality assurance plan to be adopted.

CEA has circulated duly approved guidelines to entire Power Sector to be adopted vide email dated: 15.03.2022.

Validity period of type tests conducted on the equipment i.e. the period for which Type Test Reports (TTRs) shall remain valid and acceptable to user/ utility provided no major change has been introduced in the basic design/ technology/ material/ mechanical construction/ functionalities of the equipment/ performance characteristic/ manufacturing process of the equipment.

The C.E.A constituted a committee with members from CEA, Power sector utilities and manufacturers to standardize the duration of validity of type tests conducted on various E & M equipment's and preparation of Model Quality assurance plan of major equipment in entire power sector and issued broad guidelines to be adopted in respect of major electrical equipment's. However the validity of type test reports of some of the distribution materials purchased which are not covered in the C.E.A guidelines, but Vendor approval has to be accorded is as follows and hence the OM.
