PREAMBLE


The Hon'ble KERC has notified the KERC (Fuel and Power Purchase Cost Adjustment) Regulations, 2022 on 21.10.2022. Further, KERC has notified the KERC (Fuel and Power purchase cost Adjustment) (First Amendment) Regulations, 2023 on 23.02.2023, published in the Karnataka Gazette on 24.02.2023.

ORDER

In accordance with provisions of the KERC (Fuel and Power Purchase Cost Adjustment) Regulations, 2022 dated 21.10.2022, the Commission, having recognized the variations in the fuel and power purchase cost in the 3rd Quarter of FY-23 (October to December-2022) decides to allow to recover FPPCA charges of 81 paise/unit for the billing quarter July-23 to September-23 and 80 paise/unit from October-23 to December-23 vide KERC Order dated 02.06.2023.

Further, in accordance with provisions of the KERC (Fuel and Power Purchase Cost Adjustment) (First Amendment) Regulations, 2023 dated 23.02.2023, BESCOM has computed FPPCA charges of 81 paise/unit on the variations in the fuel and power purchase cost in the month of August-23.

Approval is hereby accorded to collect the quarterly FPPCA of 80 paise and monthly FPPCA of 81 paise (total 101 paise) per unit in all the energy bills to be issued to the consumers in the billing month of October-2023 in respect of all category of consumers.
