Sub :Relief to MSME/Non-MSME Industrial Sector Consumers. Ref:(1) GOK order No:Energy/187 PSR 2021 dated 21.06.2021.

In continuation to the corporate office E-mail under reference(2), this is to inform you that, Government of Karnataka in its Order No Energy 187 PSR 2021 dated 21.06.2021 has announced following reliefs to MSME/Non-MSME Industrial Consumers:-

- For MSME Industrial Consumers the Fixed/Demand charges for the consumption months of May-2021 and June-2021 (June-2021 & July-2021 bills) is waived-off.
- 2) For Non-MSME Industrial Consumers-- the Fixed/Demand charges for the consumption months of May-2021 and June-2021 (June-2021 & July-2021 bills) is deferred till 31.7.2021.

Copy of the GOk order is herewith enclosed for reference. The waiver of Fixed/Demand Charges benefit shall be extended to the eligible MSME Industrial consumers and accounted in the System (CCB/TRM systems) by selecting and passing the correct adjustment type "COVID-19: MSME Waive off on Demand/Fixed Charges".

Since bills in June-2021 is already issued, any of the Non-MSME consumers who wish to make payment of June -2021 bills excluding Fixed/Demand Charges, the same shall be considered and accepted.

Further the terms & conditions mentioned in GOK Order, and the instructions given vide Corporate Office circulars No GM(R)/DGM(R-2)/ BC-22/2225(3)/2020-21/CYS-04 dated 18.05.2020 (SI No 4 to 8) & No GM(R)/DGM(R-2)/ AGM(R-1)/BC-22/2225(3)/2020-21/CYS 17 dated 20.01.2021 for extending the benefits to MSME/Non-MSME Industrial consumers shall be followed strictly.

A duly audited and certified consolidated statements in the prescribed formats shall be sent to corporate office on or before 10th of next month for onward submission to Government for claiming reimbursement. Any laxity/failure to adhere to the above instructions shall be viewed very seriously and the amount shall be recovered through R1 Account of the concerned official which may please be noted.

Sub: Relief to the MSME / Non-MSME industrial sectors consumers in the State of Karnataka for mitigating the impact of the COVID-19 lockdown.

Preamble:

- 1. In view of the spread of COVID-19 virus, lockdown was imposed with effect from 29.04.2021 and the same has been extended from time to time. Several restrictions have been imposed due to the Lockdown on movement of public and opening of the offices and establishments etc., to control the spread of the COVID-19 pandemic. In this time of crisis, and due to the unprecedented situation which is likely to continue for some time, the consumers are finding it difficult to pay their dues to ESCOMs on-time.
- In order to mitigate the impact of the COVID-19 lockdown, the Government of Karnataka has decided to give certain reliefs to the MSME / Non-MSME industrial electricity consumers for the months of May and June 2021 and hence this Order,

Govt Order No: ENERGY 187 PSR 2021, Bangalore, Dated: 21.06.2021

Under the circumstances stated above, Government is pleased to accord approval to give following reliefs to the MSME / Non-MSME industrial electricity consumers for the months of May & June 2021:

- 1. The Demand / Fixed Charges payable by electricity consumers who are recognized as MSME industries and hold valid certificate in that regard can avail waiver of demand / fixed charges for the months of May and June 2021 and such benefits shall also be extended to:
 - a. All the MSME Industries functioning in Rented Sheds (by accepting valid MSME Certificate along with valid / renewed rental agreement. i.e from the date of original renewed rental agreement). However, lapsed agreement cannot be accepted and the address mentioned in the rental agreement shall match with unit address as mentioned in MSME certificate and in the R.R dockets.
 - b. All the units/plants mentioned in the MSME certificate.

 The Demand / Fixed charges payable by industries other than MSME industries i.e Non MSME industries for the month of May and June 2021 shall be deferred untill 31.07.2021.

This Order is issued as per the concurrence of the Finance Department vide Note No: FD 223 Exp-1/2021 dated 17.06.2021.
